Whereas the Tilak Maharashtra Vidyapeeth (Trust) is willing to start Bachelor of Physiotherapy course (4 and ½ year course) at Indutai College of Physiotherapy , Pune under Maharashtra University of Health Sciences and as per the norms of Maharashtra State Council of Occupational Therapy & Physiotherapy (MSCOTPT), affiliation with well-equipped hospital having multi speciality / super-specialty with the capacity of more than 300 beds is must for clinical training. Whereas the Party of the Second Part running the super specialty hospital in Pune area more than twelve year and having the capacity of 330 beds and the infrastructure required for requisite training to the students of Physiotherapy course. One of the members of party of second part shall be appointed as invitee member of board of studies of TMV (Trust). The said member shall coordinate activity of the training of students of the TMV. As per the MOU party of the Second Part shall provide clinical /hospital training to the students from Tilak Maharashtra Vidyapeeth (Trust), for period of 5 years and the Party of the First Part shall send Physiotherapy students for the purpose of training and experience to the hospital of the party of the Second Part. The party of the Second Part hereby assures to provide the said training to the Physiotherapy course without any interruption Party of the Second part if due to any case the reasons unable to provide such training in their hospital, then in such case the Party of the Second Part shall give the full co-operation for making alternative arrangement for training to the students of the Party of the First Part on the same terms and conditions.



Both the parties may cancel or terminate the present MOU by giving Three Months prior notice in writing to each other


